

ORDINANCE NO. 95-02 (OTG)

AN ORDINANCE CONFIRMING THE APPOINTMENTS FOR NON-ELECTED MUNICIPAL OFFICERS AND COMPENSATION OF THE MAYOR, ALDERMEN, CLERK, CHIEF OF POLICE AND ALL OTHER MUNICIPAL OFFICERS.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF STERLINGTON, hereby confirms and approve the appointments of Scott Bardin as Mayor Pro Tempore, Mike Smith as Street and Drainage Commissioner, Cliff Bullock to serve as Commissioner of Bartholomew Sewer District #1, Marilyn Dilmore as Town Clerk and Tax Collector, Neal Johnson as Town Attorney and Court Magistrate.

FURTHERMORE, the compensation shall be fixed for the Mayor, Aldermen, Clerk, Chief of Police and all other municipal officers:

Mayor - \$450. monthly salary, \$75. auto expense monthly, plus \$100. for insurance monthly.

Aldermen - \$50. for regular meeting, \$12.50 special meeting (Maximum pay per month not to exceed \$62.50 per month).

Chief of Police - \$1,450. monthly salary, plus \$100. for insurance monthly.

Town Clerk - \$1,100. monthly salary, plus \$100. for insurance monthly.

Town Attorney/Court Magistrate - \$75. hourly.

Mayor Pro Tempore - (See compensation for Aldermen).

Street and Drainage Commissioner - no compensation.

Bartholomew Sewer Commissioner - no compensation.



Bartholomew Sewer Commissioner - no compensation.


